Bidders must submit along with their bids Firm/Company Registration Certificate, Business Registration Certificate (License), PAN/VAT Registration Certificate, Tax clearances certificate for the F/Y 2081/82 or Tax return submission evidence or evidence of tax time extension for, Power of Attorney, self-declaration letter and Letter of Bid.

Electronic bids must be submitted through PPMO website www.bolpatra.gov.np/egp on or before **12 HOURS** on 2025/12/14, 28 Manshir 2082. The bids will be opened at **1 pm**, 2025/12/14, 28 Manshir 2082 at **Gauriganga Municipality Office, Chaumala, Kailali**. Bids must be valid for a period of **90** after bid opening and must be accompanied by a bid security or scanned copy of the bid security in pdf format in case of e-bid, amounting to a minimum of as mentioned above which shall be valid for 30 days beyond the validity period of the bid.

If the last date of purchasing and/or submission falls on a government holiday, then the next working day shall be considered as the last date. In such case the validity period of the bid security shall remain the same as specified for the original last date of bid submission.
